**Park closes at 8 PM.**

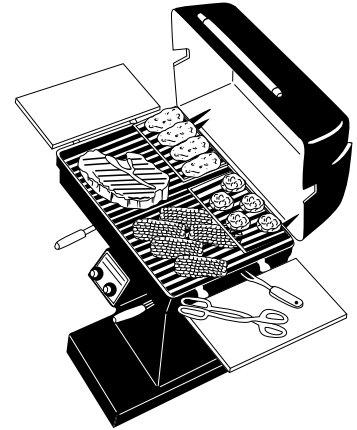
**What to Bring?** We would ask that people coming would bring something to share – salads, chips and dips, crackers and cheese, etc.

As per advice after reading and speaking with the NYS Gaming Commission, please make sure that if you intend to sell any raffle tickets for the Temple please do so only in the counties that are contiguous to the Temple. Other counties that subside in the Oriental district such as Warren, Hamilton, Essex and Clinton are NOT contiguous counties and raffle ticket should not be sold in these areas due to it would then put Oriental Temple in a unlawful position subjected to penalties and even court actions.

### — Answers to April 2014 Questions —

1. In the picture from 1936, you have future Shriner and Potentate, Ill. W. Harry Prout (1978) (and his sister Marion, also known as "Corky.")

2. Although the Shriners Hospitals for Children are located in just three countries (U.S., Canada and Mexico), the health care system has a global reach and support. Shriners' physicians and clinicians often travel to far-away places to help children in need of medical communities. Also, physicians and medical professionals often travel to the Shriners hospitals to attend seminars and get involved in educational opportunities

An example of this is that of Edward Muller, MD, an orthopedic surgeon and emeritus chief of staff and Peter Smith, MD, an orthopedic surgeon of the Chicago Shriners Hospital, who established the Silver Service Children's Foundation in 1993. The Foundation sent a team of 15 medical professionals to Colombia on a nine-day mission of teaching and healing twice a year. The team members from all over North America, are or have been on staff or a trainer at various Shriners Hospitals for Children.
